This one-day live conference will explore the effects of Hepatitis C co-infection, a common issue effecting approximately one-third of all individuals infected with HIV. As HIV treatment has improved, HCV-associated diseases have emerged as prominent co-morbidities impacting the health and survival of co-infected individuals. New agents that demonstrate potent activity against several strains of Hepatitis C in ongoing clinical trials are on the cusp of FDA approval and will likely revolutionize the treatment of Hepatitis C. Clinicians who treat co-infected patients will soon face perplexing questions regarding how to coordinate treatment for both HIV and HCV. Research has begun to unravel the complex interactions between HIV infection, immune dysregulation, metabolic complications of antiretroviral medication use, and cardiovascular disease. Specific markers of cardiovascular disease in the context of HIV infection have been identified along with preliminary strategies to reduce CVD risk.

Head to Toe: Orthopaedic Aspects of the Growing Child

Many common pediatric orthopaedic problems, such as hip and back pain, can result in poor outcomes when not promptly diagnosed or treated. Fear of poor outcomes often results in unnecessary and invasive testing by practitioners less familiar with these conditions. This course will present pediatricians and family physicians with current information on the diagnostic processes for these conditions using an algorithm-based approach. Concussion, a much discussed topic and a cause for concern in athletes at all levels of sport prompted the Federated Council of the California Interscholastic Federation to pass a bylaw in 2010 that requires a player suspected of having a concussion to produce written medical clearance to return to play. The course will assist primary care providers in making these return-to-play decisions. To ensure that attendees correctly apply splints to pediatric fractures, the course provides an opportunity to interact with experts in the field and participate in hands-on workshops.


